Holds will prevent you from registering for future classes, sending/receiving transcripts, or other services from the college.
- Not attending class or stopping payment on a check is not considered an official withdrawal from the college and you will be responsible for all tuition liabilities.
- There will be a late payment fee of 1.5% assessed per month on all outstanding balances. Outstanding debts may be referred to a licensed collection agency and all collections fees may be added to the outstanding balance. If legal action becomes necessary, litigation and all court costs will be your responsibility to pay.
- International Students here on a Student Visa must visit the Office of International Student Services, Business & Liberal Arts Center, Room B103 before leaving the college.
