► Overview of Program

:: Purpose

○ **(Purpose)** Promote the domestic introduction and diffusion of cutting-edge technologies that are difficult to develop independently due to a lack of domestic technological base and innovation capabilities through R&D support exclusively for foreign invested companies.

- **(Eligibility)** Foreign-invested companies (host organizations) and domestic industry-academia-research (joint organizations) consortia pursuant to Article 2 (Definition) 1 of the 'Foreign Investment Promotion Act'

*Foreign-invested companies with a foreign investment ratio of 50% or more and a domestic research institute

- **(Fields)** semiconductors, displays, secondary batteries, future mobility, core materials, intelligent robots, advanced manufacturing, aviation/defense industry, advanced bio, new energy industry

*Next-generation nuclear power is an industry subject to foreign investment restrictions.

○ When selecting a new R&D project, the agreement period is concluded as a lump sum for the entire R&D period of the relevant R&D project, and can be divided into stages from 1 to 4 years in consideration of the traits of the R&D project.

► How to apply, application submission deadline and reception location

:: The person in charge of research must go online, enter all project information (application items) into the computer by 18:00 on the application deadline, upload documents to be submitted, and only submit R&D plans (projects) with a status of 'submission complete'. As a rule. Entering computerized information and uploading documents may take at least an hour, and no relief is available for assignments not completed within the period (no application delay).
